# New access policy

To improve security and ensure free-flowing traffic during operations, all vehicles must be registered online via the Logipass platform to be granted access to delivery areas and to exhibitor car parks (only for Paris le Bourget, Paris Nord Villepinte)

## **DURING SET UP AND DISMANTLING PERIODS**

and for deliveries during the event's opening times (specific timetables)

**If you don't know the license plate number of your vehicle :** you can fill in a request and later add on the number (up to your arrival time).

**If you don't know your precise arrival time:** you can choose an estimated time on your preferred day (without exceeding authorized duration). It will then adjust to your exact arrival time.

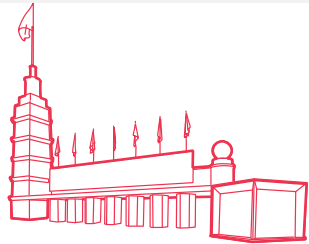

# Details by venue

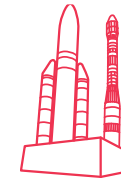

1 In the « Participant » tab, select « My access request »

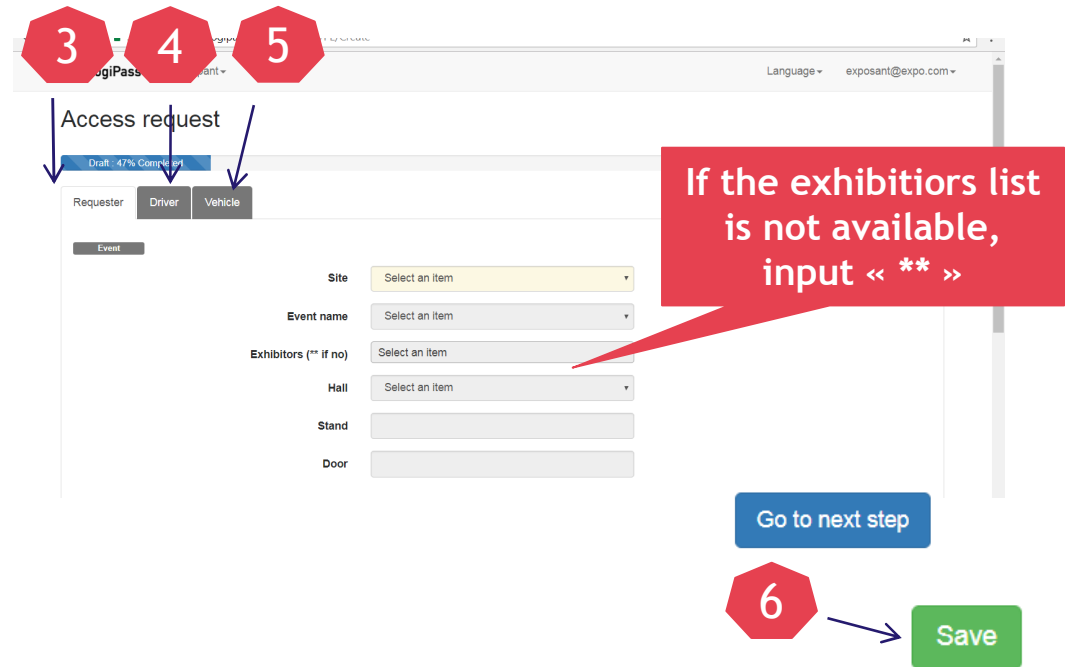
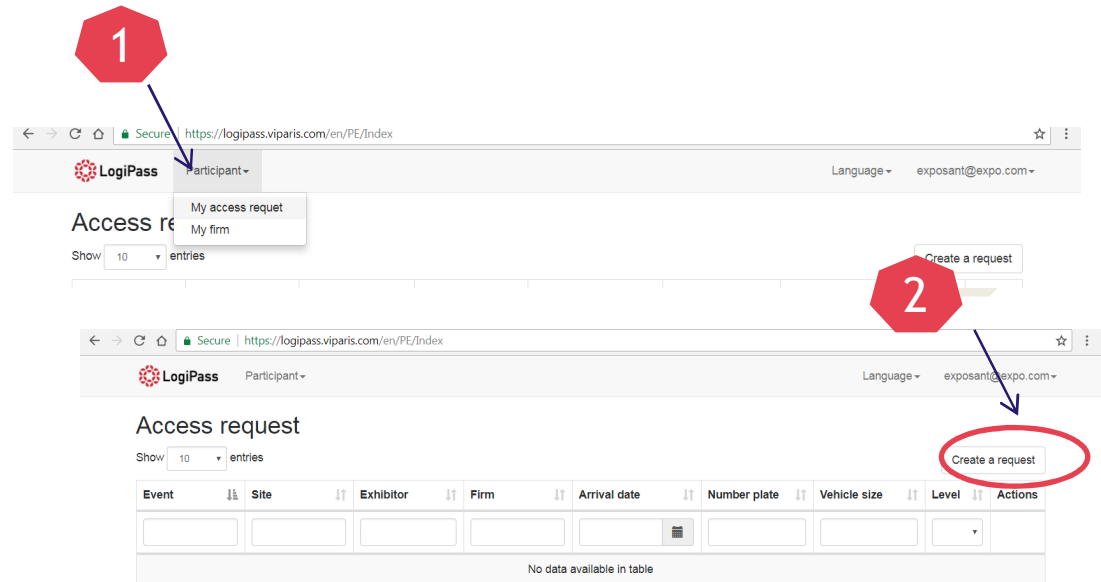
2 Click on « Create a request »

# Creating an access request 2/2

**7** Your request is now 100% completed. You can review your information before clicking on « Time slot selection»

**8** Select your timeslot and adjust it with the arrows (on tablets, press for 1 second to let the arrows appear).

Red = full timeslot

White = available timeslot

Grey = exemption needed

In the event of a mistake, choose « Delete the selected timeslot »


**9** Click on « Submit »

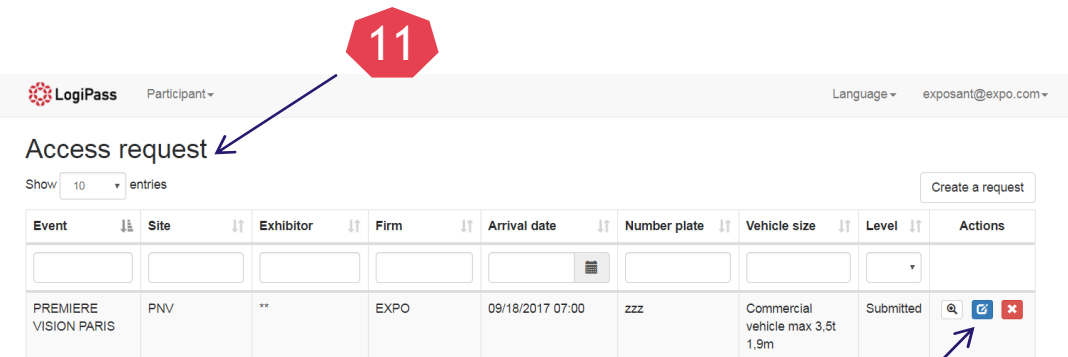
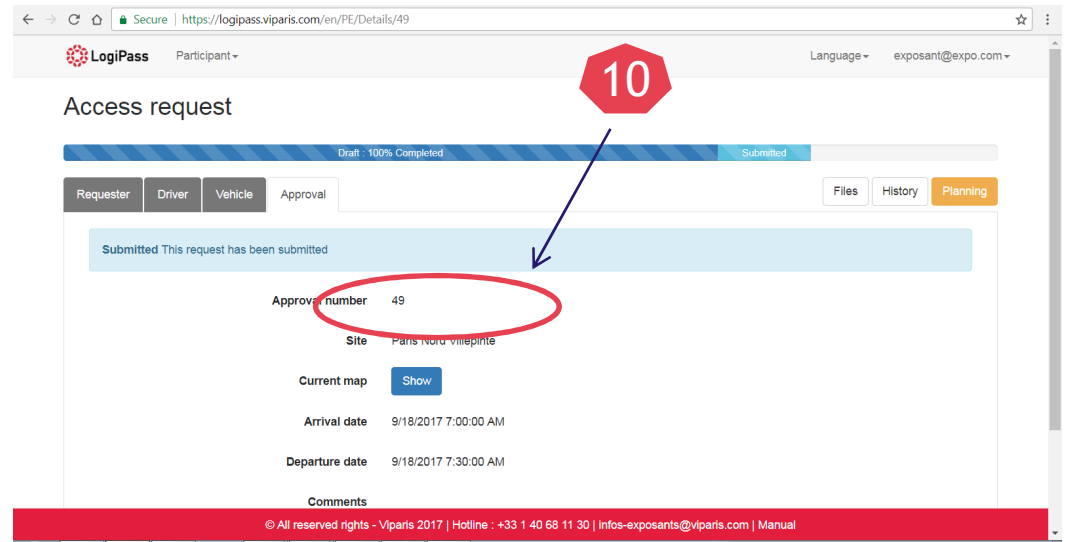
